## Chapter-I

#### REPORT OF THE CPA EX-CO MEETING

The Commonwealth Parliamentary Association was founded in 1911 as the Empire Parliamentary Association. The CPA consists of over 180 Legislatures from across the globe, divided into 9 (Nine) geographic regions of the Commonwealth. The aim of the Association is to deepen the Commonwealth's pledge to the highest standards of democratic governance and parliamentary practice.

The Constitution of the CPA vests in an Executive Committee the control and management of the activities and business of the Association. The CPA Executive Committee meets just prior to and just after the General Assembly, to which it reports, and the CPA Executive Committee holds a second meeting in another Commonwealth country midway between General Assemblies.

The CPA Executive Committee consists of approximately 36 Members led by the Chairperson of the CPA and comprising the Officers of the Association (who include the Chairperson of the Commonwealth Women Parliamentarians (CWP), the CPA Small Branches Chairperson and the Commonwealth Parliamentarians with Disabilities Chairperson) and three Regional Representatives from each Region, except the CPA Africa Region which, as the largest Region in the Commonwealth, has six Regional Representatives. The CPA Executive Committee is supported by four subcommittees: CPA Coordinating Committee, CPA Audit Committee, Planning & Review Subcommittee and the Finance Subcommittee.

The first proposal of holding the International CPA Mid-Year Executive Committee Meeting was formally made by the former Hon'ble Speaker of Assam Legislative Assembly Shri Hitendra Nath Goswami, who was then the Member of the CPA Executive Committee and Chairman of CPA India Region Zone-III at the Executive Committee meeting of CPA India Region Zone-III held on 07-10-2018 at Vivanta by Taj, Khanapara, Guwahati. The Executive Committee of CPA India Region Zone-III accordingly unanimously adopted a resolution to request the Hon'ble Speaker, Lok Sabha, Smt. Sumitra Mahajan for approving the proposal for holding the CPA ExCo. The then Hon'ble Speaker, Lok Sabha Smt. Sumitra Mahajan agreed to the resolution and accordingly the matter was taken up with the CPA Headquarters which also agreed to the proposal. However, due to COVID, the International ExCO meeting which was supposed to be held in Guwahati in 2020 could not be held.

Shri Biswajit Daimary was elected as the new Speaker of the Assam Legislative Assembly on 21st May, 2021. He was nominated as Regional Representative of the International CPA Executive Committee by the Hon'ble Speaker, Lok Sabha Shri Om Birla on 13th July, 2021 to complete the remaining term of Shri Hitendra Nath Goswami, former Speaker, Assam Legislative Assembly Shri Biswajit Daimary, Hon'ble Speaker, Assam Legislative Assembly after consulting with the Hon'ble Chief Minister, Assam Dr. Himanta Biswa Sarma discussed about hosting the next Mid-Year ExCo meeting in Assam with Shri Om Birla, Hon'ble Speaker, Lok Sabha and obtained verbal approval thereon. Further in the next Executive Committee meeting held virtually, Hon'ble Speaker, Assam Legislative Assembly had reiterated the offer for hosting the 2022 Mid-Year ExCo Meeting.

In the CPA Executive Committee meeting held virtually on 27-30 September, 2021, the Executive Committee reviewed the matter of CPA Assam State Branch, India Region hosting the Mid-Year ExCo 2022. The Executive Committee welcomed the renewed offer by the CPA Assam State Branch to hold the Mid-Year ExCo, 2022 meeting and wrote a letter to the Acting Chairman & Hon'ble Members of the Executive Committee. Finally, after thorough coordination and virtual meetings the dates for the International Mid-Year CPA Executive Committee Meeting was fixed for 9th 10th April, 2022.

Mr. Stephen Twigg, Secretary-General and Ms. Emily Davies, Head of Strategy, CPA Sectt. Office, London visited Guwahati from 15th to 18th February 2022 for a pre Executive Committee site visit and relevant discussion on logistical and other arrangement with regard to holding of the ExCo meeting. From the CPA India Region Sectt, New Delhi, Shri Yumnum Arun Kumar, Addl. Director and Bishwash Anand, Protocol Officer had also joined the CPA Hqrs team for a recce for both the events, CPA ExCo and 8th CPA India Region Conference. Shri P.C Koul, Additional Secretary, Lok Sabha Sectt. also came to Guwahati on a three-day pre-ExCo visit, i.e from 25–27 March, 2022 for assessment of both the events.

The CPA Executive Committee meeting was opened by the Chairperson of the CPA India Region and Hon'ble Speaker of Lok Sabha, Shri Om Birla. The Executive Committee meetings were held in Hotel Radisson Blue, Guwahati. The Executive Committee meeting was attended by delegates from 53 different Commonwealth countries all over the world.

## **ExCO** meetings and Sub-Committee meeting details:

## Chapter-II

# 8<sup>th</sup> CPA India Region Conference

Hosted by the Assam Legislative Assembly, the 8th Commonwealth Parliamentary Association (CPA) India Region Conference was held in Guwahati, Assam from 10 to 12 April 2022. The Conference brought together Commonwealth Parliamentarians to share their experiences of parliamentary democracy with a special focus on youth engagement.

The meeting of the Executive Committee of CPA India Region was held at Radisson Blu Hotel on 10<sup>th</sup> April, 2022. The Chairperson of the CPA India Region and Hon'ble Speaker of Lok Sabha, Shri Om Birla delivered the Inaugural Address on 11<sup>th</sup> April, 2022 in the Assam Assembly Hall. Acting CPA Chairperson, Hon. Ian Liddell-Grainger also attended the Conference. The opening ceremony was also attended by the Hon'ble Chief Minister of Assam, Dr. Himanta Biswa Sarma and the Hon'ble Speaker of the Assam Legislative Assembly, Shri Biswajit Daimary delivered the Welcome Address.

The CPA India Region General Assembly met in Guwahati on Monday, 11 April, 2022 at 1800 hours.

The 8<sup>th</sup> Commonwealth Parliamentary Association India Region Conference had intensive discussions on the following **2 topics**:-

- 1. 'Mainstreaming Youth Centric Policies' and
- 2. 'Harnessing Youth Energy for National Development and the Common Good'.

The General Assembly unanimously passed the following **Resolution**:

"All Legislative Bodies should organize appropriate programme on the subjects 'Mainstreaming Youth Centric Policies' and 'Harnessing Youth Energy for National Development and the Common Good' as a part of Amrit Mahotsav being celebrated to commemorate 75 Years of Independence of India. Youth from every section of the

society should be involved in these programmes with a view to spread universal awareness about these important subjects".

The total delegation size comprising the Presiding Officers, Secretaries and Officers of all State Legislatures of India: 233 persons. ACS Officers and Assistant Professors of different colleges were detailed on protocol duty with all the delegates.

The Conference concluded successfully with vote of thanks from the Hon'ble Deputy Speaker, Assam Legislative Assembly.

During the Conference, sightseeing/excursion was also organized for the delegates of both the international and India Region Conference to Borengajuli and Panery Tea Gardens as well as Pobitra Wildlife Sanctuary as per the choice of the delegates. This is planned as a way to showcase the rich culture and diverse natural beauty of Assam and for the delegates to experience the lives of the Assamese people first hand. The cultural programmes were appreciated by one and all, especially the international delegates.

- 2. CPA, Assam Branch may explore the possibility of Online Parliamentary Professional Development Courses in collaboration with a university, especially Law University and CPA Parliamentary Academy.
- 3. Special courses for the Legislators and Legislative Assembly Staff to provide with knowledge of how an effective Legisture can adjust facilities and process to be as given accessible as possible for persons with disability.
- 4. Youth Parliament and Women Parliament may be organized to strengthen the roots of democracy in India in general and particularly in Assam.
