to repeal The Assam Rajib Gandhi University of Cooperative Management Act, 2010.

**Preamble**

Whereas it is expedient to repeal The Assam Rajib Gandhi University of Cooperative Management Act, 2010.

Assam Act  
No. XXV of  
2010

It is hereby enacted in the Seventy-fourth year of the Republic of India as follows:-

**Short title,  
extent and  
commencement**


1. (1) This Act may be called The Assam Repealing Act, 2023.
- (2) It shall extend to the whole of the state of Assam.
- (3) It shall come into force at once.

**Repeal and  
savings**

2. The Assam Rajib Gandhi University of Cooperative Management Act, 2010 shall stand repealed from the date of commencement of this Act.
3. Notwithstanding such repeal, of the Act as mentioned in sub-section (1) above, anything done or any action taken under this Act as repealed, shall be deemed to have been validly done, taken or passed under the corresponding provisions of the Act so repealed
4. (1) After the commencement of this Act, all the properties of Assam Rajib Gandhi University of Cooperative Management shall be placed in the Sibsagar University situated at Jaysagar, Sibsagar.  
(2) After the commencement of this Act all the Officers and Staff against the sanctioned posts of Assam Rajib Gandhi University of Cooperative Management shall be placed and absorbed in the Sibsagar University for the remaining term of their service in the manner as may be provided in the Sibsagar University Act, 2023 :

Provided that the Vice-Chancellor of the Rajib Gandhi University of Cooperative Management shall be appointed as the Advisor of Higher Education Department, Government of Assam for his remaining term of office. He shall continue to draw the existing pay and allowances as admissible as the Vice-Chancellor of the Rajib Gandhi University of Cooperative Management.
