Preamble Whereas, it is expedient further to amend the Majuli University of Culture Act, 2017, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Seventy-seventh year of the Republic of India as follows :-

| Short title and commencement | 1. (1) This Act may be called the Majuli University of Culture (Amendment) Act, 2026.
(2) It shall have the like extent as the principal Act.
(3) It shall come into force at once. |
| Amendment of the title | 2. In the principal Act, in the title, for the words and figure "The Majuli University of Culture Act, 2017", the words and figure "The Majuli University Act, 2017" shall be substituted. |
| Amendment of the long title | 3. In the principal Act, in the long title, for the words "teaching and affiliating Cultural University", the words "teaching and affiliating University for Arts, Science, and other academic disciplines" shall be substituted. |
| Amendment of Preamble | 4. In the principal Act, in the Preamble, in the first line, for the words "teaching and affiliating Cultural University", the words "teaching and affiliating University for Arts, Science, and other academic disciplines" shall be substituted. |
| Amendment of section 1 | 5. In the principal Act, in section 1, in sub-section (1), for the words "Majuli University of Culture Act", the words "Majuli University Act" shall be substituted. |
| Amendment of section 2 | 6. In the principal Act, in section 2, in clause (s), for the words "Majuli University of Culture", the words "Majuli University" shall be substituted. |
| Amendment of section 3 | 7. In the principal Act, in section 3, in sub-section (1), for the words "Majuli University of Culture", the words "Majuli University" shall be substituted. |
| Amendment of section 4 | 8. In the principal Act, for the section 4, the following shall be substituted, namely-
"4. The University shall have the following objects:—
(i) to provide for instruction and research in Humanities, Social Sciences, Science and Technology, Commerce, Management, and other general academic disciplines, in addition to the study of culture and performing arts;
(ii) to promote education and training in various spheres of knowledge for the advancement of society;
(iii) to serve as a center for fostering excellence in academic and creative pursuits." |
| Amendment of section 5 | 9. In the principal Act, in section 5, in clause (a), for the words "to provide for guidelines in creative arts and allied branches of learning", the words "to provide for guidelines in Arts, Science, and other branches of learning and research" shall be substituted. |

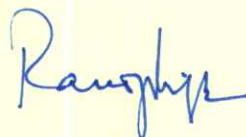
The Bill seeks to amend Section 1,2,3,4 & 5 of the Majuli University of Culture Act 2017.
