Autumn Session 2022 BULLETIN NO. 1 BRIEF RECORD OF PROCEEDINGS Monday, THE 12th September, 2022

The Assembly met at the Assembly Chamber Dispur at 0.30 A.M. M.

The Assembly met at the Assembly Chamber, Dispur at 9.30 A.M. Monday, the 12th September, 2022 with the Hon'ble Speaker, Shri Biswajit Daimary in the Chair.

The day was devoted for transacting the Government Business.

OBITUARY REFERENCES

The Hon'ble Speaker took up the first of the Agenda of the Sessional Calendar viz. "Obituary Reference". The House condoles the demises of the following eminent personalities, who left for their heavenly abode recently and observed one minute silence as a mark of respect and pray for eternal peace of the departed soul.

STARRED QUESTIONS

Starred Question No. 1,2,3,4 were disposed of with supplementaries thereto.

Starred Question No. 5 to 20 could not be taken up orally as the Question Hour was over. However, the said Questions were deemed to have been laid on the table of the House with replies thereto.

UNSTARRED QUESTIONS

Unstarred Question Nos. 1 to 50 except Question No. 11, 14 and 18 were laid on the table of the House with replies thereto.

Unstarred Question No. 11, 14 and 18 were marked as "Not Related to the Department" and hence could not be taken up.

ADJOURNMENT MOTION

The Hon'ble Speaker informed the House that he has received three notices of Adjournment Motion out of which one notice has been tabled by Hon'ble Member Shri Debabrata Saikia and 18 others of INC, one by Hon'ble Member Shri Akhil Gogoi and one by Hon'ble Member Shri Hafiz Basir Ahmed and 8 others of AIUDF respectively.

Hon'ble Speaker informed the House that the subject matter of both the notices served by Shri Debabrata Saikia and others as well as Shri Akhil Gogoi is same which is about the decision adopted by the State Govt. regarding English as a medium of teaching for Science and Mathematics from class –III onwards. Thereafter both the Members spoke on the admissibility of the Motion. Hon'ble Members Shri Rakibul Hussain and Bharat Chandra Narah also spoke on the matter.

The Hon'ble Speaker after listening to all the Members supporting the motion made his submission that the subject matter raised by the Hon'ble Members through Adjournment motion is very important but discussion on that matter should not interrupt the proceedings of the House and it can be brought through another device for discussion. The Opposition bench then created an uproarious scene demanding discussion on the matter through Adjournment motion which resorted the Chair to Adjourn the House for 10 minutes at 10.52 am.

The House resumed at 11.02 am with the Hon'ble Deputy Speaker in the Chair.

As soon as the House resumed, Hon'ble Member Shri Aminul Islam raised that the subject matter of the third notice served by the Hon'ble MLA Hafiz Bashir Ahmed and others was about people living in the char Areas and the allegation imposed upon them as encroachers and requested a decision from the Chair on it.

Taking note of the facts stated by the members, the Hon'ble Deputy Speaker informed the Hon'ble Member that subject matter is under consideration and he will be informed in due course of time.

The House then again witnessed noisy scene as the Members of the AIUDF Legislature Party insisted upon an immediate decision from the Chair

Taking his seat, Hon'ble Speaker requested the Hon'ble Minister, Parliamentary Affairs to speak on the admissibility of the notice served by the Hon'ble Member Shri Debabrata Saikia and 18 others as well Hon'ble Member Shri Akhil Gogoi.

Accordingly, Hon'ble Minister, Parliamentary Affairs, informed the House, that since the matter in question is of public importance, it can be taken up through another device during the current session of the Assembly.

Reiterating to the notice of Adjournment Motion, Hon'ble Member Shri Aminul Islam requested the Chair to facilitate a discussion during the day.

As the Hon'ble Speaker refused to give his consent to admit the notice as there are ample opportunity raise the issue through other devices, the Members of the AIUDF Legislature Party staged a walkout in protest of the Ruling by the Chair.
