BRIEF RECORD OF PROCEEDINGS
Wednesday, the 7th February, 2024

The Assembly met at the Assembly Chamber, Dispur at 9.30 A.M. Wednesday, the 7th February, 2024 with the Hon'ble Speaker, Shri Biswajit Daimary in the Chair.

STARRED QUESTIONS

Starred Question Nos. 21 to 28 were disposed of with supplementaries thereto. Starred Question Nos. 29 to 40 could not be taken up as the Question Hour was over. However, the said Questions were deemed to have been laid on the table of the House with replies thereto.

As the clock struck 2 P.M, the Hon'ble Speaker extended the House for half an hour with the sense of the House, so that the discussion on the "Motion of thanks on the Governor's Address" could be disposed of within the stipulated time.

GOVERNMENT RESOLUTION

Hon'ble Speaker informed the House that as the, Hon'ble Minister has to leave the House for attending an urgent pre-occupied Government business, the business enlisted in Sl. 11 (Resolution) of the list of Business for the day, may be taken up for disposal, ahead of other items.

Accordingly, being called upon by the Chair, Hon'ble Minister Shri Chandra Mohan Patowary (Environment & Forest etc.) moved for leave to pass a Resolution authorizing the Parliament to amend the Water (Prevention and Control of Pollution) Act. 1974 under Article 252 (1) of the Constitution of India, as given below;

"Whereas the Parliament had enacted the Water (Prevention and Control of Pollution) Act, 1974 (No. 6 of 1974) providing for prevention and control of water pollution and the maintaining or restoring of wholesomeness of water, for the establishment, with a view to carrying out the purposes aforesaid, of Boards for the prevention and control of water pollution, for conferring on and assigning to such Boards powers and functions relating thereto and for matters connected therewith.

AND WHEREAS certain shortcomings in the operation of the law have been noticed which require amendments to the Water (Prevention and Control of Pollution) Act, 1974 (No. 6 of 1974).

AND WHEREAS the subject matter of such a law is provided under List-II (State List) of the Seventh Schedule to the Constitution of India and Parliament has no power to make laws for the States with respect to the aforesaid matters except as provided in Articles 249 and 250 of the Constitution of India.

AND WHEREAS it appears to this Legislative Assembly to be desirable that the aforesaid amendments in the Law should be made in the State of Assam by Parliament by amending the law.

NOW, THEREFORE in exercise of the powers conferred by clause (2) of Article 252 of the Constitution of India this House hereby resolves that 'The Water (Prevention and Control of Pollution) Amendment Bill, 2023' may be introduced in the Parliament and amended provisions made by the Parliament by such law be applicable in the State of Assam."

Thereafter, the Chair put the Resolution before the House and the House passed the resolution in voice vote.

As soon as the Hon’ble Member Dr. Rafikul Islam completed his speech, the Chair Adjourned the House at 2.30 P.M. till 9.30 A.M. on Thursday, the 8th February, 2024.


