BRIEF RECORD OF PROCEEDINGS
Thursday, the 8th February, 2024

The Assembly met at the Assembly Chamber, Dispur at 9.30 A.M. on Thursday, the 8th February, 2024 with the Hon'ble Speaker, Shri Biswajit Daimary in the Chair.

STARRED QUESTIONS

The Question Hour started at 9.30 A.M. Starred Question Nos. 41 to 49 were disposed of with replies thereto.

Starred Question No. 50 to 60 could not be taken up orally as the Question Hour was over at 10.30 A.M. However, the said Questions were deemed to have been laid on the Table of the House with replies thereto.

UNSTARRED QUESTIONS

Unstarred Question Nos.88 to 137 were laid on the table of the House with replies thereto.

DISCUSSION AND VOTING ON DEMANDS FOR GRANTS

Immediately after the Question Hour, the Hon'ble Speaker took up the next item i.e. Discussion and Voting on Supplementary Demands for Grants and called upon the Hon'ble Minister, Revenue and Disaster Management to move the Demand for Grant pertaining to his Department.

Accordingly, the Hon'ble Minister, Revenue and Disaster Management Shri Jogen Mohan moved Grant No. 6 pertaining to Revenue and Disaster Management for granting an additional amount of Rs.1152.79 lakh to defray certain charges during the year ending 31st March,2024.

Once the Hon'ble Minister, Revenue and Disaster Management Shri Jogen Mohan moved the Demand, the Hon'ble Speaker requested the Hon'ble Members to move their Cut Motion notices.

During the course of the discussion, Hon'ble Chief Minister also made a speech clarifying the stand on certain policies of the Government.

The Hon'ble Minister, Revenue and Disaster Management, Shri Jogen Mohan made his reply covering all the issues raised during the discussion on Supplementary Demand for Grants. Later being satisfied with the reply of the Hon'ble Minister, the Hon'ble Members concerned withdrew their Cut Motions and the Demand for Grant No-6 was passed with the leave of the House.

After the discussion and disposal of Grant No-6, the Hon'ble Speaker put the remaining Grants in Guillotine, as the time for Guillotine was reached. and put the remaining Supplementary Demand for Grants were subsequently passed by the House on voice vote.

INTRODUCTION, CONSIDERATION AND PASSING OF "THE ASSAM APPROPRIATION (NO.I) BILL, 2024

Upon being called by the Chair, the Hon'ble Finance Minister, Smti Ajanta Neog, introduced, "The Assam Appropriation (No.I) Bill, 2023."

The Bill was then taken into consideration clause by clause and the House passed the Bill on Voice Vote.
