1. GOVERNMENT RESOLUTION ON THE ASSAM STATE CAPITAL REGION DEVELOPMENT AUTHORITY ACT, 2017

This is for kind information of the Hon'ble Members that the following resolution has been admitted under Rule 117 of Rules of Procedure and Conduct of Business, Assam Legislative Assembly for taking up in the House during the current session of the Assam Legislative Assembly.

Shri **Ashok Singhal**, Minister (Housing & Urban Affairs etc.) to move the following:-

“Whereas The Assam State Capital Region Development Authority Act, 2017 (**Assam Act No. 38 of 2017**) was passed by the Assam Legislative Assembly on 15th September, 2017 and the Act was notified vide LGL.234/2017/5 dated 25.10.2017. The Act which has been brought in force to provide for the establishment of a Regional Development Authority for the preparation of a Regional Plan for the development of the Assam State Capital Region and for purpose of co-ordinating and supervising the proper, orderly and rapid development of the areas in that Region and for executing plans, projects and schemes for such development, and to provide for matters connected therewith.

AND WHEREAS The Act under Sub Section (2) of Section (1) provides that it shall extend to the Assam State Capital Region area as specified in the schedule appended to the said Act. In the Schedule and Annexure of the Act, areas under five districts namely Kamrup Metropolitan District, Kamrup District, Nalbari, Darrang and Morigaon have been mentioned under entries at serial no. 1 to 5 respectively. In serial no. 5 of the Schedule and Annexure appended to the Act, Morigaon District's Mayong and Morigaon Circle (excluding Tiwa Autonomous Council areas except Jagiroad Development Area) has been included under the Assam State Capital Region area (pursuant to Assam State Capital Region Development Authority (Amendment) Act, 2020.

However, for administrative and other incidental reasons the Government now feels it will be expedient to exclude the entire Tiwa Autonomous Council area from the purview of the Assam State Capital Region area.

Legislative Department viewed that, Section 2 (c) of the Assam State Capital Region Development Authority Act, 2017 specifies that the department can amend the Schedule by notification in the Official Gazette, but the said notification prior to its publication have to be laid before the House of state Legislature and has to be approved by resolution passed by the House in this matter and thereafter that can be published in the Official Gazette. No Bill is required to be placed for amendment of the said Schedule.

Accordingly, the proposal has been approved by the Hon'ble cabinet in its meeting held on 23/09/2023.

NOW, THEREFORE in exercise of the powers conferred in section 2(c) of Assam State Capital Region Development Authority Act, 2017, it is proposed to amend the entry at Sl. No. 5 of the Schedule, and Annexure I, by excluding the entire Tiwa Autonomous Council area from the purview of the Assam State Capital Region area by publication of the Notification in the official Gazette. Draft Notification vetted by Legislative Deptt is Annexed at **Annexure-A.**”

The Resolution as received from the Department of Housing & Urban Affairs, Government of Assam has uploaded in Members’ Portal on **09/02/2024.**
