BRIEF RECORD OF PROCEEDINGS
Thursday, the 22nd February, 2024

The Assembly met at the Assembly Chamber, Dispur at 9.30 A.M. Thursday, the 22nd February, 2024 with the Hon'ble Speaker, Shri Biswajit Daimary in the Chair.

STARRED QUESTIONS

Starred Question Nos. 161 to 168 were disposed of with supplementaries thereto.

As the Question Hour was over, the remaining Question Nos. 169 to 180 could not be taken up orally. However, the said Questions were deemed to have been laid on the table of the House with replies thereto.

UNSTARRED QUESTIONS

Unstarred Question Nos.326 to 375 were laid on the table of the House with replies thereto.

ADJOURNMENT MOTION

Immediately after the Question Hour, Hon'ble Leader of the Opposition wanted to know from the Chair, about the fate of the Notice of Adjournment Motion under Rule 56 of the Assembly Rules which was submitted by the Congress Legislature Party.

In response, the Hon'ble Speaker informed the House that he had received two notices of Adjournment Motion on a similar subject, one from Shri Debabrata Saikia Hon'ble Leader of the Opposition alongwith Hon'ble Members of INC and another from Hon'ble Member Shri Akhil Gogoi. He informed the House that as the Hon'ble Members will get ample opportunities to raise the subject in question under various other devices, he could not admit the Notice at this stage. Quoting relevant Rules and making references from the Practice and Procedure of Parliament, Hon'ble Speaker stated that Adjournment Motions are normally not allowed during Budget discussions and the Motion of Thanks on the Governor's Address, as the Members get sufficient opportunities to focus the attention of the House to any matter during such discussions.

As the Hon'ble Leader of the Opposition and other signatory Members of both the notices insisted the Hon'ble Speaker to reconsider his decision, Hon'ble Speaker agreed to hear the Hon'ble Members concerned on the admissibility of the Notices.

Accordingly, Hon'ble Leader of the Opposition, Shri Debabrata Saikia, Hon'ble Member Shri Rakibul Hussain and Hon'ble Member Shri Akhil Gogoi spoke in substantiation of the admissibility of the Notice.

Hon'ble Speaker also heard the Hon'ble Parliamentary Affairs Minister on the admissibility of the Adjournment Motion.

The Hon'ble Speaker after hearing the Hon'ble Members concerned as well as Hon'ble Minister, Parliamentary Affairs, disallowed the Notices reiterating to his stand.

REPORT OF THE BUSINESS ADVISORY COMMITTEE

Hon'ble Speaker announced the Report of the Business Advisory Committee containing the decisions of the Business Advisory Committee taken at its meeting held on 21st February, 2024 with regard to Business for the Budget Session, 2024 of the Assembly.

ADJOURNMENT OF THE HOUSE

As the Hon'ble Members from the Opposition benches were not satisfied with the Ruling of the Hon'ble Speaker on the Adjournment Motion and stalled the Proceedings of the House , the Hon'ble Speaker adjourned the House for 10 minutes at 10.42 am

LAYING OF REPORT

As soon as House was resumed at 10.55 A.M. Hon'ble Speaker laid the Report on the participation of CPA Assam State Branch at the 66th Commonwealth Parliamentary Conference in Ghana from 30th September to 6th October, 2023.

DISCUSSION AND VOTING ON DEMAND FOR GRANTS

Taking up the item No. 4, the Hon'ble Speaker called upon the Hon'ble Minister, Women and Child Development Department, Smti Ajanta Neog to move the Demand for Grant pertaining to her Department.

The Hon'ble Minister, Women and Child Development, Smti Ajanta Neog made her reply covering all the issues raised during the discussion on Demand for Grant, 2024-25.

On being asked by the Chair, whether the movers of the Cut Motion, will withdraw their Cut Motion,- Hon'ble Members Shri Hafiz Bashir Ahmed and Shri Manoranjan Talukdar withdrew their Cut Motions. However, Hon'ble Leader of the Opposition and other Members who moved the Cut Motion as well as Hon'ble Member Shri Akhil Gogoi refused to withdraw their Cut Motions and staged a walk out from the House. Later the Grant No. 39 was passed by the House on voice vote.

As the House reached the stipulated time for disposal of the Voting on Demands for Grants, 2024-25, the Hon'ble Speaker put the remaining Grants before the House and the grants were passed by the House on voice vote.

INTRODUCTION, CONSIDERATION AND PASSING OF "THE ASSAM APPROPRIATION (NO.II)BILL,2024"

The Hon'ble Speaker then called upon the Hon'ble Finance Minister, Smti Ajanta Neog, to introduce "The Assam Appropriation (No. II) Bill, 2024."

Accordingly, the Hon'ble Minister, Finance introduced the "The Assam Appropriation (No. II) Bill, 2024." with the leave of the House

The Bill was then taken into consideration clause by clause and the House passed the same on Voice Vote.

SHORT DURATION DISCUSSION UNDER RULE-50

Being called upon by the Hon'ble Speaker, the Hon'ble Member Shri Bhaskar Jyoti Baruah raised a discussion under Rule-50 of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly on a matter of Public Importance regarding "Need to take effective and concrete measure in a time bound manner to make the state of Assam Carbon Neutral well before the year 2050 and to overcome the problem of environmental pollution in the state being caused due to gradual deforestation, illegal

mining, felling of trees for use as timber and other environmental hazards” and spoke on the matter.

Hon’ble Members Shri Diganta Barman, Shri Bharat Chandra Narah and Shri Manoranjan Talukdar also participated in the matter raised by the Hon’ble Member Shri Bhaskar Jyoti Baruah.

Hon’ble Minister, Science, Technology and Climate Change Department, Shri Keshab Mahanta, made an exhaustive statement before the House clarifying the stand and position of the Government.

The House then stood adjourned at 4:05 P.M. till 9:00 A.M. on 23rd February, Friday, 2024.
