BRIEF RECORD OF PROCEEDINGS
Friday, the 23rd February, 2024

The Assembly met at the Assembly Chamber, Dispur at 9.00 A.M. Friday, the 23rd February, 2024 with the Hon'ble Speaker, Shri Biswajit Daimary in the Chair.

STARRED QUESTIONS

Starred Question Nos. 182 to 193 except Question Nos. 181, 183, 187 and 191 were disposed of with replies thereto.

Starred Question Nos. 181,183,187 and 191 could not be taken up due to the absence of the Questioners and hence deemed to have been laid on the table of the House.

As the Question Hour was over, the remaining Question Nos. 194 to 200 could not be taken up orally. However, the said Questions were deemed to have been laid on the table of the House with replies thereto.

UNSTARRED QUESTIONS

Unstarred Question Nos.376 to 425 were laid on the table of the House with replies thereto.

DISCUSSION ON ZERO HOUR

Four matters of Public Importance were raised in the House during the Zero Hour.

Hon'ble Member Shri Ramendra Narayan Kalita raised a matter which was published in "Amar Asom" dated 20-02-2024 under the caption :-“ভবলু উন্নয়ন, ভবলু পুনৰ্জ্জীৱিতকৰণ।” and spoke on it. Hon'ble Minister, Housing and Urban Development, Shri Ashok Singhal made a statement in reply to the matter raised.

Hon'ble Member Smti. Sibamoni Bora raised a matter which was published in "Dainik Agradoot" dated 19-02-2024 under caption :-“দেশত৭৩,৩১৮মেগাৱাটৰ বিপৰীতে অসমত১৫৬মেগাৱাটহে সৌৰশক্তি উৎপাদন” and spoke on the matter. Hon'ble Minister of Power Smti. Nandita Gorlosa replied to the matter so raised.

Hon'ble Member Shri Nurul Huda raised a matter which was published in "Dainik Gana Adhikar" dated 22-02-2024 under the caption :-“এম ই, হাইস্কুললৈ ৰূপান্তৰিত হোৱা মাদ্ৰাছা সমূহৰ পদ প্ৰাদেশীকীকৰণত বঞ্চিতা।”and spoke on it. Hon'ble Education Minister Dr. Ranuj Pegu replied to the matter raised.

Hon'ble Leader of the Opposition Shri Debabrata Saikia on behalf of Shri Bharat Chandra Narah, Shri Wazed Ali Choudhury, Shri Diganta Barman and Shri Pradip Sarkar, raised a matter which was published in "Dainik Janambhumi" dated 22-02-2024 under the caption :- “বেদখলকাৰীলৈ কাৰ্বি স্বায়ত্ত পৰিষদৰ উচ্ছেদৰ জাননী” and spoke on the matter. Hon'ble Minister of Revenue and Disaster Management Department, Shri Jogen Mohan replied to the matter.

CALLING ATTENTION

Hon'ble Member Shri Sherman Ali Ahmed called the attention of the Government under Rule 54 of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly relating to a matter under the caption :-

“গুণোৎসৱৰ নামত মন্দিয়াত শিক্ষা বিভাগৰ আজৰ কাণ্ড-শিক্ষকৰ ভূমিকাত চকীদাৰ, বৰপেটাত ক্ষুদ্ৰ অভিভাৱক”।

Hon'ble Minister, Education etc. Dr. Ranaj Pegu replied to the matter raised.

Not being satisfied with the reply, Hon'ble Members Shri Sherman Ali Ahmed and Shri Ashrafal Hussain disrupted the proceedings of the House by creating disturbances. As a result, the Hon'ble Speaker suspended both the Members from the House till completion of that item.

SPECIAL MENTION UNDER RULE - 301

Two matters of Public importance were raised under Rule 301 (Special Mention) of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly.

Hon'ble Member Shri Abdul Batin Khandakar brought a matter to the notice of the House under the caption :- “অসম সমগ্ৰ শিক্ষা অভিযানৰ অন্তৰ্গত সৰ্বাত্মক শিক্ষাৰ জৰিয়তে প্ৰদান কৰা দিব্যাংগ সকলৰ শিক্ষা আৰু এই প্ৰক্ৰিয়াত নিয়োজিত সহকাৰী সমলব্যক্তি (ARP) আৰু অতিৰিক্ত সহকাৰী সমলব্যক্তি (AARP) সন্দৰ্ভত”। Hon'ble Education Minister Dr. Ranaj Pegu made a statement regarding the matter raised by the Hon'ble Member.

Hon'ble Member Shri Aminul Islam (Sr.) raised a matter which was published in “Gana Adhikar” dated 06-02-2024 under the caption :- “মিছামাৰীত অনলাইন জুৱাৰ ব্যাপক পয়োভৰে ধ্বংস কৰিছে নৱ-প্ৰজন্মৰ জীৱন”। On behalf of the Hon'ble Chief Minister, Hon'ble Parliamentary Affairs Minister Shri Pijush Hazarika made an elaborate reply regarding the matter.

INTRODUCTION OF PRIVATE MEMBER'S BILL

Hon'ble Member Shri Akhil Gogoi introduced “The Assam Quality Education Bill, 2024” with the leave of the House.

PRIVATE MEMBERS' RESOLUTION

Being called upon by the Chair, the Hon'ble Member Shri Akhil Gogoi moved his resolution to make Assam a twelve month cultivating state by supplying water to the fields at all times.

The following Hon'ble Members participated in the discussion:-

1. Shri Aminul Islam (Sr.), AIUDF
2. Shri Manoranjan Talukdar, CPI (M)
3. Shri Jakir Hussain Sikdar, INC

Shri Ashok Singhal, Hon'ble Minister of Irrigation replied to the debate.

After reply of the Hon'ble Minister, the Hon'ble Member Shri Akhil Gogoi refused to withdraw his Resolution. The Chair then put the Resolution for voice-vote.

However, as the Hon'ble Member Shri Akhil Gogoi and other Members of the Opposition benches demanded for division, the Chair called for a division and adjourned the House for 10 (ten) minutes to facilitate voting process.

Later, as soon as the House resumed, the Resolution was again put to vote by voice vote. However, division was again demanded. Accordingly, division was held by distribution of slips. The result of Division Ayes- 39 and Noes-30 was announced by the Chair. Accordingly, the Resolution was rejected.

The House was then adjourned at 12.20 P.M. till 2.00 P.M.

After the House resumed at 2.00 P.M. the Hon'ble Member Shri Rekitabuddin Ahmed moved the Resolution "*regarding preserving rare species of birds in Assam like Greater Adjutant, Lesser Adjutant and Vulture before they become extinct*".

On behalf of Hon'ble Forest Minister, Hon'ble Parliamentary Affairs Minister Shri Pijush Hazarika clarified all points of the Resolution and made an elaborate reply.

After the reply of the Hon'ble Minister, the Hon'ble Member withdrew his Resolution. The Chair allowed the withdrawal with the sense of the House.

Hon'ble Member Shri Sherman Ali Ahmed moved his Resolution "*for immediate closure of the Baghbar cattle market illegally run by private parties causing loss of crore of rupees of revenue*".

Hon'ble Parliamentary Affairs Minister on behalf of the Hon'ble Minister, P&RD, made a reply on the Resolution moved by the Hon'ble Member.

After the reply of the Hon'ble Minister, the Hon'ble Member refused to withdraw his Resolution and the same was rejected on Voice -Vote.

Hon'ble Member Shri Diganta Barman moved his Resolution "*to provide unemployment allowances to unemployed youths of Assam according to their merit to meet their other expenses*".

The Hon'ble Parliamentary Affairs Minister on behalf of the Minister concerned made a statement regarding the Resolution. After the reply of the Hon'ble Minister, the Hon'ble Member withdrew his Resolution.

Hon'ble Leader of the Opposition moved the Resolution "*that those who want to study in English Medium should be taught in English and those who want to study in vernacular medium should be taught in their mother tongue*".

The Hon'ble Education Minister Dr. Ranoj Pegu made an illustrative reply on the Resolution. Being satisfied with the reply of the Hon'ble Minister, the Hon'ble Member withdrew his Resolution, the Chair allowed the withdrawal with the sense of the House.

Hon'ble Member Shri Aminul Islam (Jr.) moved a Resolution "*to provide minimum required land to the landless people and one house each under the Pradhan Mantri Awas Yojana*".

Hon'ble Members Shri Jakir Hussain Sikdar (INC) and Dr. Rafiqul Islam (AIUDF) also participated in the discussion.

Hon'ble Minister, Revenue and Disaster Management Shri Jogen Mohan made an elaborate reply on it.

After the reply made by the Hon'ble Minister, the Hon'ble Member withdrew the Resolution.

Hon'ble Member Shri Jakir Hussain Sikdar moved the Resolution "*to provide pension to all farmers over the age of 60 years in Assam and spoke on the matter*".

Hon'ble Parliamentary Affairs Minister, Shri Pijush Hazarika, on behalf of Shri Atul Bora, Agriculture Minister made a reply.

Being satisfied with the reply given by Hon'ble Parliamentary Affairs Minister Shri Pijush Hazarika, the Hon'ble Member withdrew the Resolution.

Hon'ble Member Shri Ashraful Hussain moved the Resolution regarding the construction of a bridge over the Brahmaputra river in Barpeta District.

Hon'ble Members Smti. Nandita Das, Shri Sherman Ali Ahmed and Shri Jakir Hussain Sikdar also participated in the discussion.

Hon'ble Parliamentary Affairs Minister Shri Pijush Hazarika on behalf of Hon'ble PWD Minister made a reply on it and the Hon'ble Member withdrew the Resolution.

SPECIAL MOTION

Hon'ble Speaker with the sense of the House announced that the item No. 14 i.e. "Special Motion" under Rule 130A which stood in the name of Hon'ble Member Shri Sherman Ali Ahmed shall be taken up in the House at a later date.

The House then stood adjourned at 4:15 P.M. till 9:30 A.M. on 26th February, Monday, 2024.
