ASSAM LEGISLATIVE ASSEMBLY BUDGET SESSION, 2024 BULLETIN NO. 12

BRIEF RECORD OF PROCEEDINGS

Monday, the 26th February, 2024

The Assembly met at the Assembly Chamber, Dispur at 9.30 A.M. Monday, the 26thFebruary, 2024 with the Hon'ble Speaker, Shri Biswajit Daimary in the Chair.

STARRED QUESTIONS

Starred Question Nos. 201 to 210 except Question Nos. 203 & 209 were disposed of with supplimentaries thereto.

Question Nos. 203 & 209 could not be taken up orally as the Questioners were absent, whereas Question Nos. 211 to 220 could not be taken up as the Question Hour was over. However, the said Questions were deemed to have been laid on the Table of the House with replies thereto.

Not being satisfied with the reply of the Hon'ble Chief Minister, on Question No. 202, the Hon'ble Members of the Opposition benches staged a walk out from the House.

UNSTARRED QUESTIONS

Unstarred Question Nos. 426 to 475 were laid on the Table of the House with replies thereto.

SHORT NOTICE QUESTIONS

Replies to the Short Notice Questions Nos. 1 to 7 were laid on the Table of the House.

ADJOURNMENT MOTION

Immediately after the Questions, Hon'ble Member Shri Karim Uddin Barbhuyan, requested the Hon'ble Speaker to take up the adjournment motion, the notice of which was submitted by himself and other Members of the AIUDF Legislature Party. Hon'ble Leader of the Opposition and other Members of the Congress Legislature Party requested to allow the Adjournment Motion, as they also have submitted notice on the same subject matter.

Hon'ble Speaker informed that he has received the Notices of Adjournment and after due consideration of the subject matter of the Notice, he observed that the matter in question has not yet come up before the House and will definitely come up before the House ahead of its implementation and the Hon'ble Members shall get ample opportunities to discuss it at that time. As such, he does not consider that the matter should be discussed under an Adjournment Motion and hence rejected the notices.

Not being satisfied with the ruling of the Chair, the Members of the Opposition benches walked out of the House.

Smti. Nandita Gorlosa, Minister, Power etc. laid the Annual Report and Accounts of 2022-23 for the financial year 2022-23 of Assam Power Generation Corporation Limited.

Shri Jogen Mohan, Minister, Mines & Minerals etc. laid the thirty sixth Annual Report for the financial year 2019-2020 of Assam Mineral Development Corporation Limited.

STATUTORY RESOLUTION

Being called upon by the Chair, Hon'ble Minister, Parliamentary Affairs etc. Shri Pijush Hazarika on behalf of Hon'ble Minister, Housing & Urban Affairs etc. Shri Ashok Singhal, moved a Statutory Resolution regarding amendment to the Schedule to the Assam State Capital Region Development Authority Act, 2017 by Government Notification under Section 2 (c) of that Act.

The Hon'ble Deputy Speaker then put the Resolution to vote before the House for approval. The House approved the same and the Statutory Resolution was adopted unanimously.
