**Subject**

1) **Shri Ramendra  
Narayan Kalita :**

Keeping in view the problem of unemployment in the State of Assam, this House urges upon the Government to take measures to recruit 100% indigenous youth in the 3<sup>rd</sup> and the 4<sup>th</sup> Grade posts in the private and the public sectors.

2) **Shri Akhil Gogoi :**

Having regards to the facts that-

- (i) the Economic Survey, Assam, 2023-24 (P.287), mentions that the number of unemployed in Assam was 22,00,125 in 2021 and the number of registered unemployed increased by 10,34,613 in one year to make the total number to 32,34,738;
- (ii) the problem of unemployment in Assam is very burning and complex;
- (iii) to provide employment to millions of uneducated youths in the State is a very challenging task,

this House urges upon the Government to frame and implement a comprehensive policy to overcome permanently the problem of increasing unemployment of the youths of the State of Assam by including 100% employment to local unemployed youths, wherever practicable in services under the State.

3) **Shri Abdur Rashid  
Mandal :**

This House urges upon the Government to revive and restore 10% quota for Economically Weaker Section in services under the Government of Assam so as to ensure compliance with the Union Government Policy of reservation for Economically Weaker Section in services as laid down in the Constitution (103<sup>rd</sup> Amendment) Act the validity of which has also been upheld by the Supreme Court in their Judgment dated- 7<sup>th</sup> November, 2022.

4) **Shri Jakir Hussain  
Sikdar :**

This House resolves that the Government should take effective steps including latest technological innovations to prevent erosion and also construct embankments on both sides of Pohumara, Palla, Kaldiya, Tihu, Burhadiya and Beki rivers flowing through Pakabetbari constituency formerly known as Sarukhetri and all the other rivers of Assam.

**5) Shri Kamalakhya  
Dey Purkayastha :**

Keeping in view that-

- (i) the population of Assam has been increasing faster than the other parts of India, specifically in a few particular districts as reflected in recent data and statistics;
- (ii) this abnormal increase in population is changing the demography of the State considerably and also affecting the socio economic growth of the State,

this House urges upon the Government to take concrete measures in a time bound manner to control the abnormal population growth in the greater interest of the people of the State.

This House urges upon the Government to increase the financial assistance provided by the Government to the families severely affected by natural calamities, especially floods and erosion to rupees three lakhs.

**7) Shri Sherman Ali  
Ahmed :**

“Whereas, the river-bed of Brahmaputra and its tributaries have become shallow for deposition of silt from the hills due to unabated shifting cultivation and indiscriminate destruction of forest and also for unabated erosion of landmass in the plains,

and whereas, erosion of Brahmaputra and its tributaries have rendered lakhs of families homeless and have washed away Government properties such as roads, bridges, schools, Mandirs, Masjids, etc. worth thousands of crores of rupees,

and whereas, erosion and floods in the State have now become an unmanageable menace,

and whereas, land and water are valuable natural resources which can be gainfully utilized for the prosperity of the State,”

this House resolves that, the Government should take immediate steps to channelize the river Brahmaputra and control the erosion of river Brahmaputra and its tributaries from Sadiya to Dhubri scientifically without any loss of time.
