Keeping in view the following anomalies as reflected in the Independent Auditor's Report contained in the Thirty Sixth Annual Report of Assam Mineral Development Corporation Limited for the year 2019-20 laid on the Table of the House on the 26<sup>th</sup> Feb, 2024 by the Minister of Mines and Minerals:-

- (i) 'in respect of sale of core mercantile item i.e. coal, to the approved customers, the controlling mechanism for selection of customers is not adequate, for which the Company may affect itself in revenue generation by hindering the entrance of new customer who can buy at higher rate' to which the reply of the management, that is, 'The area of operation for coal extraction is heavily infested with extremists' is factual untrue;
- (ii) 'Debtors amounting to Rs.37,76,247/- are very old and do not appear to be realizable;
- (iii) 'The corporation has made a provision of Rs.30,51,790/- against CSR activities, without actually incurring any expenditure, even though it is legally required to do so under Section-135 of the Companies Act, 2013; and
