

<u>Name of Members</u>	<u>Subject</u>
1) Shri Abdul Batin Khandakar	“This House urges upon the Government to grant special package to mitigate the development disparity of the <i>Char</i> areas of Assam.
2) Shri Hafiz Bashir Ahmed Shri Aminul Islam (Sr) Shri Ashraful Hussain	Against the backdrop of growing unemployment and with a view to encourage self employment, this House urges upon the Government to frame and implement a policy to give one time financial assistance of at least five lakh rupees to every unemployed youth of Assam having graduate/post graduate degree for entrepreneurship.
3) Shri Abdur Rashid Mandal	This House urges upon the Government to modify/withdraw the Government Notification No.FOR/SETT/484/58/327 dated 23 rd October, 1959 so as to denotify the Proposed Reserve Forest (PRF) land in Goalpara District and takes steps to convert the earlier notified PRF land in Goalpara District into revenue land and allot such land to genuine permanent residents of Assam living in such PRF land and to government and public institutions having offices on such PRF land.
4) Shri Abdul Batin Khandakar	This House urges upon the Government to come forward with a Bill to provide rehabilitation and resettlement of families affected by river erosion in Assam. (An Amendment received and printed on separate list)
5) Shri Nurul Huda	This House urges upon the Government to take immediate steps to remove all sorts of discrimination in land related transaction between individuals in the interest of strengthening the constitutional and democratic system.
6) Shri Sherman Ali Ahmed	“Whereas thousands of people across communities, cast, creed and religion in Assam have lost their precious lives due to communal clashes/ police firing, Whereas next of kin of most of the affected families are yet to be rehabilitated with adequate compensation, And whereas ours being a welfare State has its bounden duty to rehabilitate these families, this House resolves that the affected families, who have not yet been rehabilitated, be compensated adequately without any further loss of time.”
