The term of the Committee shall be for a period of one year with effect from 9th September, 2026 or till a new committee is constituted in accordance with the rules.

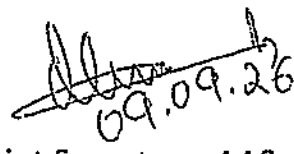
