Shri Narendra Kumar Shah, IAS, District Magistrate, Nagaon, vide communiqué No. NMM. 17/2025/NSA/84 dated 14-05-2025 has forwarded a copy of the detention order issued under Section 3(2) of the National Security Act, 1980 and in compliance with the provisions of Section 8(1) of the said act against Shri Aminul Islam, MLA, Dhing LAC which is reproduced below:

### **Detention Order**

Whereas, a report has been received from the Superintendent of Police, Nagaon, vide Memo No. Memo No. IV/NGN/Detention/2025/1354 dated 02/05/2025, along with supporting documents and intelligence inputs, indicating that Shri Aminul Islam, MLA Dhing, S/o Late Mufti Khairul Islam, Vill.- Paramaibheti, PS- Juria, District Nagaon, has been engaging in activities prejudicial to the maintenance of public order and the security of the State;

And whereas, it has been reported that Shri Aminul Islam delivered a provocative public speech on 23/04/2025 during a Panchayat election campaign at a village Jamuguri, Alitangoni under Juria Police Station, and that a video of his statement alleging government conspiracy in past terrorist attacks has circulated widely, resulting in the registration of Nagaon PS Case No. 347/2025 dated 24/04/2025 under relevant provisions of law;

And whereas, I, Narendra Kumar Shah, IAS, District Magistrate, Nagaon, upon careful examination of the material placed before me, am satisfied that the said individual is likely to continue engaging in activities prejudicial to public order and the security of the State;

And whereas, the Government of Assam, in exercise of the powers conferred under Section 3(3) of the National Security Act, 1980, has vide Notification No. HMA.135/2023/48 dated 14/10/2023, delegated the powers under Section 3(2) of the said Act to the District Magistrate, Nagaon;

Now, therefore, in exercise of the powers so delegated, I do hereby direct that Shri Aminul Islam be detained under Section 3(2) of the National security Act, 1980, and be lodged in the Central Jail, Nagaon, with immediate effect.

He is further informed that he has the right to make a representation against this detention order to the State Government and to the Advisory Board constituted under Section 9 of the National Security Act, 1980, in accordance with Section 8(1) of the said Act.

The grounds for this order, along with the material particulars on which it is based, shall be communicated to Shri Aminul Islam as soon as possible, and in any case, within five days from the date of detention, or within ten days in exceptional circumstances, as per Section 8(1) of the National Security Act, 1980.

This order is issued in compliance with the provisions of the National Security Act, 1980, and Article 22(5) of the Constitution of India.
