Sir,

With reference to the subject cited above, I have the honour to inform you that a case has been registered in Nagaon PS against Shri Aminul Islam, MLADhing LAC on 24/04/2025 and has been arrested in connection with the above referred case.

The Brief History of the Sou-Moto FIR and the ground of arrest is mentioned below:-

**Brief of the case:-**

The complainant Inspector Debojit Das, O/C Nagaon PS filed an FIR stating that Shri Aminul Islam, Member of Legislative Assembly representing Dhing LAC, has made public statements that are seditious, misleading, and potentially detrimental to the unity and integrity of our nation.

**Ground of Arrest:-**


1. Dissemination of False Allegations: A video circulating on social media and press platforms features Shri Aminul Islam accusing the Central Government of India of orchestrating the Pahalgam terrorist attack, which was perpetrated by Pakistan-sponsored terrorists and resulted in the death of 28 innocent individuals.
2. Public Speech at Jamuguri, Alitangoni: On April 23 2025, during a Panchayat election campaign meeting held in village Jamuguri, Alitangoni under Juria Police Station, Shri Aminul Islam publicly alleged that the Pulwama Attack on February 14, 2019, was a conspiracy by the Government of India and its key functionaries.
3. By spreading such rumours, misinformation and hatred Information, the MLA Shri Aminul Islam intentionally, purposely has excited the public, thereby endangering unity and integrity and social fabric of the Country, which may led to instability in the Country. The MLA has intentionally provoked the general public by infusing hatred feelings against the Stable Public Elected Central Government which may lead to fall of the Central Government in the wake of shocked waves which the Country is presently witnessing since the day of Pahalgam Incident.
4. He has made misleading information, jeopardizing the sovereignty, unity, integrity and security of the country.
