ORDER

In pursuance of Article 188 of the Constitution of India, I, Shri Lakshman Prasad Acharya, Governor of Assam, hereby appoint Shri Chandra Mohan Patowary, a Member of the Sixteenth Assam Legislative Assembly, as the person before whom the Members of the said Assembly shall make and subscribe their oath or affirmation according to the form set out for the said purpose in the Third Schedule of the Constitution, until a Speaker is elected.

After the election of the Speaker of the Assembly, the oath or affirmation shall be made and subscribed before the Speaker of the said Assembly and in his absence before the Deputy Speaker or when the Assembly is in session and both the Speaker and Deputy Speaker are absent, before the person who may be presiding over the Assembly for the time being.
