INTRODUCTION

Hon'ble Speaker, Assam Legislative Assembly, has been pleased to form an All Party Delegation under his leadership to study the situation arising out of the indiscriminate firings by Mizoram Police at Lailapur area of the Cachar district of Assam on 26th July 2021 wherein 6 Assam Police personnel lost their lives & many other personnel including the Superintendent of Police, Cachar sustained serious injuries and still under hospitalization in different Hospitals across the country and even the IGP (T&AP) & Deputy Commissioner of Cachar were also injured resulting in tense situation in the area, the Hon'ble Speaker considered it necessary to form an All Party Delegation to visit the places of occurrence to take stock of the situation with a view to Report the House about the facts as follows;

REPORT

The All Party Delegation headed by Hon'ble Speaker Assam Legislative Assembly left for Silchar on 31st July 2021. The Delegation on its arrival at Silchar Circuit House held a discussion with the Senior Officials of the Police Department and District Administration of Cachar on the issue.

The Delegation also met a few representatives of various ethnic societies of the locality and heard their complaints on the subject in question and visited the place of occurrence for physical verification of the case.

Narrating the incident, Shri Anurag Agarwal, IGP (T&AP), Assam Police enlightened the Delegation that land encroachments, violations in the form of making new construction of Camps/Roads etc. in the occupied land by Mizoram within the constitutional boundary of Assam was at the root of the discord resulting in the sad incident of 26th July 2021.

On 25/07/2021 D.F.O. Cachar Division submitted a requisition for Police Force Vide Memo No. B/13/(O.R)/4165 dtd. 25/07/2021 to accompany him for his assistance. It was stated in requisition that temporary camp of Mizoram Police and an unauthorised road is being constructed inside Reserve Forest of Assam viz. Inner Line Reserve Forest violating Forest Laws. Also, notices were to be served to officials of Mizoram based on preliminary offence report registered by DFO Cachar U/S 24, 25 and 59 of Assam Forest Regulation Act, 1891. Accordingly, a joint team of District Administration led by Deputy Commissioner Cachar Smti Kreeti Jalli, DFO Cachar Shri Tejas Mariswamy and consisting of Inspector General of Police (T&AP) Shri Anurag Agarwal, IPS and Deputy Inspector General of Police (SR) Assam, Silchar Shri D. Mukherjee, IPS, Superintendent of Police, Cachar, Shri Vaibhav C. Nimbalkar, IPS, and other police, forest and civil ranks went to the aforesaid Reserve Forest of Dholai Range of Cachar Forest Division.

On way near the site forest officials started issuing notices for the violations seen by them. However, the Mizo persons refused to accept the notices. In no time, near the site, the team encountered Mizoram Police in heavy numbers headed by Superintendent of Police, Kolasib Shri Vanlafaka Ralte, Addl. SP Kolasib L David, Addl. S.P Bruce, SDPO Kolasib Tharte Hrangchal, MPS and some civil officials. There were discussions between Assam and Mizoram side about violation of status quo. Also, the Assam team tried to serve the notices which were refused to be accepted by Mizoram officials. This lasted for more than

two hours. During this time, miscreants from Mizoram side Vairengte town and surrounding areas gathered there with sharp weapons, catapults and air guns and started attacking the on-duty Assam Government officials and grievously injured several of them. They also damaged the Assam Govt. property by attacking the vehicles. Mizoram Police was asked to control their civilians as they were taking law in their hands. However, no efforts were made by Mizoram Police to control the mob consisting of miscreants from their side. Infact Mizoram police vacated the spot and went behind the Mizo miscreants. To control them warning was given but in vain. Later some tear gas shells were also fired to control the unruly mob. However, SP Kolasib Vanlafaka Ralte who stayed back with some of his personnel was again asked to control the civilians. After about half an hour, he received a phone call and left the discussion midway and vacated the spot.

Just after he left, suddenly there was an unprovoked heavy firing from automatic weaponry including machine guns from Mizoram side, aimed at Assam Government officials present. Thereafter, Assam Police took position and fired in self-defense. However, since the Mizoram Police under the leadership of SP Kolasib Vanlafaka Ralte, IPS, and accompanying miscreants were on high ground, Assam Police had to suffer the losses. From the attacking style of Mizoram, it could be apparently said that it was nothing but a cold-blooded massacre leading to heavy casualties towards the State of Assam. Sharing his experience, the IGP submitted before the Delegation that never in his service life he has met such an incident of cold-blooded massacre perpetrated by any Armed Force in the country using the machine guns from the high ground on both sides of the main road, continuously for about more than half an hour on Assam Police personnel. As the firing from Mizoram side was from well secured high grounds, without any provocation from Assam Police and also under the guise of negotiation, it took some time to Assam Police team to take position and retaliate. In the first spurt of firing, Assam Police has to suffer major losses. Assam Police was positioned on the location which was much lower than that of the Mizoram police personnel who were positioned on secured high grounds in the area under their occupation. He also told that it could be seen that Mizoram is executing all sorts of construction works including multiple roads and infrastructures in the Reserve Forest land within the territory of Assam violating all the norms prescribed for the Reserve Forest under the Forest Act. As Mizoram has constructed multiple roads in the area under their occupation on Assam Mizoram Border, by violating all norms, they have a far better connectivity and can reach

the border areas much faster and easier in comparisons to Assam, which has maintained its Reserve Forest area as per law.

The Delegation afterwards heard the representatives of various Organizations of the ethnic societies at Silchar Circuit House.

The President, Kachari Unnayan Parishad enlightened the Delegation about the activities perpetrated by the Mizo activist to encroach the land under the territory of Assam. He has requested the Delegation to take necessary steps for protection of the territorial boundary of State of Assam as well as the residents of the locality.

The President Bru (Reang) People Forum while explaining the hardship faced by the people residing in the inter state border area due to encroachment by the Mizoram people producing land documents issued by the Mizoram Government has requested the Delegation to take necessary action for safety and security of the citizens of the locality.

After a great deal of deliberation from both the sides including the Hon'ble Members representing the respective constituencies of the Barak Valley Districts, Hon'ble Speaker expressed that Assam Government is always respectful towards the law enacted upon under the Constitution of India. It is undoubtedly admittable that there are some primitive laws which were framed during the British regime and which are still in force has caused hindrances in undertaking the developmental activities. Citing the example of Forest Act, he added that this act has caused hindrances in building up the basic infrastructure like roads etc. in the areas under the jurisdiction of Reserve Forest. However, some of our neighbouring states have undertaken some policies going against the relevant law. He expressed that the constitutional inter-state territorial boundary should be inviolable and believed that the Government of Assam would definitely take urgent measures to solve the issue amicably.

The Delegation then visited the Lailapur area for the physical verification of the situation that arose after the incident. The Delegation has heard complaints of various Organizations of that locality and expressed that the Delegation has come here to have a first-hand knowledge of the incident and is fully concerned with the safety and security of the people of that locality.

Afterwards, the Delegation left for Dholai Forest IB and held another meeting with the Government Officials and the Hon'ble Members present there.

The Delegation then proceeded to Silchar Circuit House and held a meeting with the Senior Officials of Police Department as well as the Officers of the District Administration besides the Hon'ble Members representing the respective constituencies under Barak Valley Districts.

There has been a great deal of deliberation with the participation of the Hon'ble Members of the Delegation including the Hon'ble Minister, Environment & Forests, Hon'ble Deputy Speaker etc. on the issue. Expressing his concern, Hon'ble Speaker stated that the unfortunate incident that took place in Lailapur area of Cachar District was totally uncalled for and hoped that such incidents would not recur in future. He stated that the Government of Assam under the leadership of Hon'ble Chief Minister has taken all necessary steps for restoration of peace and normalcy in the area and to ensure security of the people of the region.

The Senior Officials of the District Administration apprised the Delegation about the measures taken up from the Government side and has informed that two police camps have already been set up, one in Kulichara another at Lailapur area which is now under the possession of neutral force. All necessary infrastructural buildup such as roads, water supply has been developing expeditiously to support the security forces deployed there under the direct supervision of the Deputy Commissioner and Superintendent of Police, Cachar besides the Senior Officials connected thereto.

The All Party Delegation expressed satisfaction over the measures taken by the Government of Assam in handling the issue.

The meeting of the All Party Delegation was ended with a consensus to stand by the Government of Assam to find out an amicable way to resolve the border dispute at the earliest.

Afterwards, a group of Members of the Delegation headed by Hon'ble Deputy Speaker visited the Silchar Medical College & Hospital to see the injured persons admitted during the Lailapur incident.

OBSERVATIONS AND POINTS OF CONSENSUS

The All Party Delegation after careful consideration of the submission made by the Officers of the Civil and Police Administration of Cachar District and representatives of various Organization of ethnic Societies as well as factual verification observes as follows:

The Delegation is convinced that the unfortunate incident which led to killings of six numbers Police personnel and serious injuries to a large numbers of government officials, both from Police and civil administration including the Senior officers like I.G.P (T&AP), Deputy Commissioner, Cachar, together with the Superintendent of Police, Cachar besides a few civilians was perpetrated by Mizoram Police.

The Delegation, therefore, unanimously condemned the vicious attack perpetrated by the Mizoram Police.

The Delegation is constrained to note that the Mizoram police along with some miscreants has indulged in encroachment activities inside the territory of the State of Assam.

The Delegation is of consensus view not to spare even an iota of land constitutionally allocated to the State of Assam.

The Delegation feels that the discord regarding inter-state boundary of the Assam and Mizoram has remained festering due to the encroachment by the neighboring state.

The Delegation unanimously held that there shall not be any compromise in the constitutionally demarcated territorial boundaries of the state of Assam which shall be protected at any cost.

The Delegation considers that the issue of encroachment of the constitutional territorial boundary of the state should be persued with the Central Government so that it can be resolved amicably.

Accordingly, it is proposed that an All Party Delegation headed by the Hon'ble Speaker would visit New Delhi soon to meet the Hon'ble Union Home Minister and other Central Leadership connected therewith.

Sub:- **REPORT ON THE INCIDENT THAT HAPPENED ON THE 26TH OF JULY, 2021 AT THE INNER LINE RESERVE FOREST OF DHOLAI RANGE OF CACHAR FOREST DIVISION.**

Sir,

Apropos to the above mentioned subject, it is being brought to your kind notice that on 25/07/2021 D.F.O. Cachar Division submitted a requisition for Police Force Vide Memo No. B/13/(O.R)/4165 dtd. 25/07/2021 (Annexure-I) stating that a temporary camp of Mizoram Police and an unauthorised road is being constructed inside Inner Line Reserve Forest violating Forest Laws. Also, notices were to be served to officials of Mizoram based on preliminary offence report registered by DFO Cachar U/S 24, 25 and 59 of Assam Forest Regulation Act, 1891. Accordingly, a joint team of District Administration led by Deputy Commissioner Cachar Smti Kreeti Jalli, DFO Cachar Shri Tejas Mariswamy and consisting of Inspector General of Police (T&AP) Shri Anurag Agarwal, IPS and Deputy Inspector General of Police (SR) Assam, Silchar Shri D. Mukherjee, IPS, Superintendent of Police, Cachar, Shri Vaibhav C. Nimbalkar, IPS, and other police, forest and civil ranks went to the Inner Line Reserve Forest of Dholai Range of Cachar Forest Division.

3. Death was due to shock following the antemortem injuries sustained, caused by impact of firearm projectile- Hav- Shyam Sundar Dausad, (6th APBn)

Present status of the injured persons is the:-


- The Superintendent of Police Vaibhav Nimbalkar Chandrakar, IPS is still admitted at Mumbai for further surgery.
- 5(five) injured police personnel are at GMCH
- and 2(two) injured Police personnel are still at SMCH

Consequently, a case was registered vide Dholai P.S. C/No 236/21 u/s 120(B), 153A, 447, 336, 379, 147, 148, 149, 333, 307, 302, 427 IPC R/W Sec 25 (1) - (A) /27 Arms Act R/W Sec 3 Prevention of Damage to Public Property Act. Accordingly, notices u/s 41A CRPC were served to all FIR named accused. Also, 91 CRPC notice is served to SP Kolasib requiring details of the personnel engaged in the act. A notice is also served to DIG CRPF u/s 91 CRPC seeking evidences collected at the Place of Occurrence as it is currently under the jurisdiction of CRPF as per Ministry Home Affairs, Govt. of India directives. A notice is also served to K Vanlalvena, M.P. Rajya Sabha u/s 41A CRPC for his appearance in connection with inflammatory and provocative statements regarding the case. Further, investigation into the case is going on. Attempts are underway to stop further encroachment.

Bn) (4) Const. Mozrul Hoque Barbhuiya (Cachar DEF) (5) Const- Nozmul Hussain (6th AP Bn.) and lost their lives. Fifty-three Assam Police personnel received different types of bullet and splinter injuries. (List enclosed, Annexure-II). Ten Civilians also received bullet and splinter injuries (List enclosed Annexure III). Among the injured is Shri. Vaibhav C. Nimbalkar, IPS, Superintendent of Police, Cachar. The PSO to Superintendent of Police, Cachar, ABC- Liton Suklabaidya unfortunately lost his life. Further on 27th of July, 2021 one more police person of 6th APBn Namely Hav. Shyam Sundar Dusad succumbed to his injuries, raising the number of deceased to six.

The firing went on for a long time despite telephonic pleads by Shri Vaibhav Nimbalkar Chadrakant, IPS, SP Cachar to Sri Vanlalafaka Ralte, MPS, SP Kolasib to ceasefire as he was himself hurt and several of his men had taken bullets. However, SP Kolashib paid no heed and the firing continued. In the meanwhile wasting no time, IGP(TAP) started the evacuation of deceased and injured from the site from the back side of the firing direction with the help of available vehicles. In this process the vehicle of IGP(TAP), DIG(SR) and available security vehicles were used. However, as the firing was still continuing from the Mizo Side and Superintendent of Police Vaibhav Nimbalkar Chadrakant, IPS and some officer injured were stranded in front side their evacuation was done with the help of bullet proof vehicle brought by DIG CRPF, Group Centre, Dayapur. Superintendent of Police Hailakandi, who was already on way as called by IGP(TAP), also reached and helped in the process of evacuation. The evacuation process continued till late night and all injured and deceased were shifted to SMCH, Silchar. Next day Shri Vaibhav Nimbalkar Chadrakant, IPS was airlifted to Mumbai for further treatment as his injury as hip joint required specialist consultation. Other serious patients namely (1) Hav- Nogen Mech, 6th APBn (2) Const. Dipanka Borah, 4th APBn (3) ABSI- Ramjit Chauhan, 21st AP(IR) Bn (4) Hav- Gopeswar Sinha, 21st AP(IR) Bn (5) Const. Ashit Kr. Das, 21st AP(IR) Bn were also airlifted to GMCH Guwahati for specialised treatment. Later, as per direction of Ministry of Home Affairs, Govt. of India, CRPF took over the site and two additional training coy's of CRPF were called in to station at the place of occurrence. In compliance of directions of Ministry of Home Affairs, Govt. of India, Assam Police retreated from the spot in the night. However, Mizoram Police is still continuing to occupy the same position Confidential information indicates that the incident is a part of a conspiracy, hatched by senior Police and Civil officials of Mizoram and political functionaries of Mizoram to disturb the public tranquility and harmony between Mizoram and Assam.

A number of vehicles including 04 (Four) nos Govt. vehicles bearing Regd. No AS-01DY-4610 (Thar) and AS-30-8837 (Bolero), AS-30—8057 (Thar) and many other hired vehicles were destroyed by the Mizo miscreants. Tents and other govt. properties in the vehicles were also stolen.

According to the collected Post Mortem reports of the deceased:

1. Death was due to Hemorrhagic shock following the bullet injury sustained which was antemortem & caused by rifled firearm.

2. Death was instantaneous following the injuries sustained to the head, which were antemortem and caused by the impact of firearm projectile – ABSI-Swapn Kumar Roy of (21st AP (IR) Bn)

Sub - Requisition of Police Force.


Sir,

With reference to the subject cited above, I would like to inform you that there has been severe encroachment and destruction of forest cover for construction of camp and roads by the IRBN Personnel in the Inner Line Reserve Forest area under the jurisdiction of Cachar Forest Division, Silchar. It is learnt that they have the backing of the Mizoram Government officials. A preliminary offence report against the Mizoram Government officials has already been registered under Section 24, 25, & 59 of the Assam Forest Regulation Act, 1891 and amendments in 1995. However, it is noticed that they have continued to destroy the forest cover and are building more camps and further extending the roads in the reserve forest.

In this regard it is kindly requested of you to provide sufficient armed personnel to accompany the undersigned and the Range Forest Officer, Hawaithang Range, Dholai to evict the Mizoram IRBN personnel from the Reserve Forest area which they have illegally occupied and to stop the activity of construction of road which is resulting in severe damage to the Reserve Forest. The Range Forest Officer, Hawaithang Range, Dholai shall also serve notices to the concerned in-charge / leader of the IRBN Personnel for offences under the said Forest Regulation Act, 1891.

This is for your kind information and necessary action.
