Introduction

- 1. The Commonwealth Parliamentary Association (CPA) is one of the oldest International Associations of the Parliamentarians from across the Commonwealth countries. Founded in 1911, it is a membership association which brings together Members, irrespective of gender, race, religion or culture, who are united by community of interest, respect for the rule of law and individual rights and freedoms, and by the pursuit of the positive ideals of parliamentary democracy. The Association is made up of over 180 Legislatures (or Branches) divided up between nine geographic regions of the Commonwealth. It offers a vast opportunity for Parliamentarians and parliamentary staff to collaborate on issues of mutual interest and to share good practices. CPA is dedicated to the standards and ideology of the Commonwealth as written in the Commonwealth Charter.
- 2. The aim of CPA is to deepen the Commonwealth's pledge to the highest standards of democratic governance and parliamentary practice. CPA's mission is "To promote knowledge of the constitutional, legislative, economic, social and cultural aspects of parliamentary democracy, with particular reference to the countries of the Commonwealth."
- 3. Good governance lies at the heart of the CPA's Mission with a keen focus on transparency, accountability, financial oversight and thorough auditing processes.
- 4. As a Member of the Executive Committee of CPA HQs representing India Region and as the head of the CPA Assam State Branch, I attended the 66th Commonwealth Parliamentary Conference (CPC) in Accra, Ghana from 30th September to 6th October, 2023 accompanied by Shri Debabrata Saikia,

PRE-CONFERENCE STUDY TOUR - EGYPT

(a) Brief Background on Political System of Egypt

Official name of the country is Arab Republic of Egypt and Cairo is the capital. Egypt has a presidential form of Government with an appointed Prime Minister. Egypt has a Bicameral Parliament –(i) Senate (Majlis Al-Shiyoukh)/Upper House with 300 members: 200 elected and the rest are nominated by the President) and (ii) House of Representatives (Majlis Al-Nuwab)/Lower House with 596 members: 568 elected and 28 nominated by the President.

The major political parties of Egypt are – Future of Nation Party (Mostaqbal Watan Party), Republican Peoples' Party, Al Wafd Party, Free Egyptian Party. Head of the State is the President Abdel Fattah Al Sisi (since June 2014) and Head of Government is Prime Minister Mostafa Madbouly (since June 2018).

Approximately, 3600 Indian community people are in Egypt, most of who are concentrated in Cairo/Greater Cairo. There are also a small number of families in Alexandria, Port Said and Ismailia.

(b) Visit to Egyptian Senate and Discussion

On 27th September, 2023 the Delegation from Assam Legislative Assembly led by Shri Biswajit Daimary, Hon'ble Speaker visited the Majlis Al – Shiyoukh (Egyptian Senate) as part of the Pre-Conference Study Tour. A delegation from the Tamil Nadu Legislative Assembly led by the Hon'ble Speaker, Tamil Nadu Legislative Assembly also visited the Egyptian Senate at the same time. After visiting the Senate, the delegation had a formal meeting with the Egyptian Senate.



Meeting between the Egyptian Senate and the Indian delegation comprising of representatives of Assam and Tamil Nadu Legislative Assemblies

At the outset, the Hon'ble Deputy Speaker of the Senate, Mr Bahaa El-Din Abu Shukka welcomed the delegation to the Egyptian Senate. In his opening remarks, he emphasized on the historical relations between India and Egypt and specifically mentioned the visit to India by the Egyptian President, Al Sisi and the Hon'ble Prime Minister of India, Shri Narendra Modi's visit to Egypt which, he said, is a sign of cooperation between the two nations at the highest level.

With regard to the Legislature, he stated that Egypt has two Houses of Legislature - the House of Representatives and the Senate. The Egyptian Constitution of 1923 is one of the best Constitutions based on the Belgian Constitution. The Constitution has been amended in 2014 to abolish the Senate but in the 2019 amendment, the Senate has been restored. The Deputy Speaker then outlined some of the practices and procedures of the Egyptian Parliament.

Shri Biswajit Daimary, Hon'ble Speaker, Assam Legislative Assembly thanked the Egyptian Senate for giving the time and opportunity for the delegation to visit the Egyptian Parliament. Stating that this is his first visit to Egypt, he expressed that the Senate is very beautiful and that it is a good experience for the delegation to visit the Egyptian Parliament and learn about its practices and procedures. He also mentioned that the delegation is on the way to attend the 66th Commonwealth Parliamentary Conference in Ghana and took this opportunity to visit Egypt and learn about the Parliamentary practices and procedures of Egypt and about its governance. He stated that in India, there are two Houses of Parliament-Lok Sabha and Rajya Sabha just like Egypt has two Houses. At the



State level, there is Legislative Assembly and local self-government at the local level. He also explained about the three lists-Union, Concurrent and State lists and how laws are made by the Central and State Legislatures on the subjects in these lists.

The ensuing discussion focused on mutual exchange of information and views about the various aspects of the legislative procedures and practices. Members of Egyptian Senate enquired about the system of functioning and relationship between the Central Government and the State Government in India and how decisions are taken. Hon'ble Speaker and the Hon'ble Leader of Opposition of Assam Legislative Assembly replied meticulously to their queries and explained about the division of power between Union and State Governments as specified in Seventh Schedule of Indian Constitution under Article 246 regarding the Central, State and Concurrent lists.

H.E. Ajit Gupte, Indian Ambassador to Egypt presented a brief account of the many high-level engagement programs and ministerial trips taken up in recent times from both sides including the visits of the Egyptian President Sisi as the Chief Guest of Indian Republic Day in January 2023 and his subsequent visit in September 2023 to attend the G20 Summit. The participants also took the privilege to discuss about the 9th G20 Parliamentary Speakers Summit (P20) and Parliamentary Forum hosted by the Parliament of India from 12 to 14 October, 2023. From the discussions, it has come to light that Strategic Partnership Agreement has been signed by Egypt and India to elevate the bilateral relationship for mutual advantages, specifically in the areas such as security, defense, energy, trade and investments, etc.

During the course of the discussions, the Hon'ble Speaker, Assam Legislative Assembly extended a warm invitation to the Egyptian Senate to make a visit to India and the State of Assam in the near future and expressed that he looked forward to meeting the Egyptian delegation in the soon to be held P-20 meeting in India.

The meeting concluded with a mutual vote of thanks.

CPA MID YEAR EXECUTIVE COMMITTEE MEETING IN ACCRA, GHANA FROM 30TH SEPTEMBER TO 5TH OCTOBER, 2023

Shri Biswajit Daimary, Hon'ble Speaker, Assam Legislative Assembly has been re - nominated as the Regional Representative from India Region in CPA Executive Committee for a 3-year term (66th CPC to 69th CPC)

(a) Ghana and its political system

The Republic of Ghana is situated on the West Coast of Africa. The capital of the Republic of Ghana is Accra. Political structure of Ghana is one of Unitary Republic and Constitutional democracy. Ghana has primarily two parties- The ruling New Patriotic Party (NPP) and opposition National Democratic Congress (NDC). The President of Ghana is both the Head of State and Head of Government. The estimated number of Indians living in Ghana is about 15000 out of which about 3000 hold Ghanaian nationality. The Legislature consists of a unicameral 275-member body plus the Speaker. Members are elected for a four year term in Single Seat constituencies by simple plurality vote.

(b) CPA International Executive Committee meetings

Shri Biswajit Daimary, Hon'ble Speaker, Assam Legislative Assembly attended the Executive Committee Meeting of the Commonwealth Parliamentary Association (CPA) as a Regional Representative nominated by the Hon'ble Speaker, Lok Sabha from CPA India Region. It is matter of great pride and honor for Assam that he is the first Speaker to be re-nominated for the second term as Executive Committee Member of CPA HQ. To attend the 66th Commonwealth Parliamentary Conference at Accra, Ghana he was accompanied by Shri Debabrata Saikia, Hon'ble Leader of Opposition, Shri Manab Deka, Hon'ble Member and Shri



Susanta Borgohain, Hon'ble Member from Assam Legislative Assembly.

As per the official record, altogether 75 (seventy five) delegates from the CPA India Region participated in the 66th CPC at Accra, Ghana. The Executive Committee Members from CPA India Region attending the 66th CPC were:

The 66th Commonwealth Parliamentary Conference was held at the Accra International Conference Centre (AICC), located directly opposite to the Parliament of Ghana, Accra from 30th September to 6th October, 2023 hosted by the Parliament of Ghana and CPA Ghana Branch. Alongside the Conference, the 39th Small Branches Conference, 66th CPA General Assembly, governing meeting of the CPA Executive Committee, meetings of the Commonwealth Women Parliamentarians (CWP), Commonwealth Parliamentarians with Disabilities (CPwD) networks and the 57th General Meeting of the Society of the Clerks-at- the-Table (SoCATT) and Conference Workshops were also held.

The theme of the Conference was: "The Commonwealth Charter 10 years on: Values and Principles for Parliaments to uphold".

The 66th CPC was attended by over 600 Parliamentarians and Parliamentary

The Vice Patron of the CPA, His Excellency Nana Akufo- Addo, the President of Ghana, urged all to work together to reflect deeply the values and principles of Commonwealth Charter and focus the discussions on the goal of attaining and maintaining the democratic ethos of this noble community as he inaugurated the 66th Commonwealth Parliamentary Conference. And he also took the opportunity to commend the Commonwealth for its commitment to the rule of law, open and tolerant societies, equality for all and respect for fundamental human rights and freedom

The CPA Secretary General, Stephen Twigg said during his speech that the Conference offers an invaluable opportunity to come together and share best practices in addressing common issues and strengthening Commonwealth values, as the theme of the Commonwealth Charter attests. The values within the Charter, and the vital role the CPA has in sustaining and reinforcing them, are as relevant today as they were when they were originally signed in 2013.

(f) 66th Commonwealth Parliamentary Conference: CPA Officer Elections

CPA Vice- Chairperson – The 66th CPA General Assembly was followed by a meeting of the new CPA Executive Committee during which Hon. Arthur Holder, Speaker of the House of Assembly of Barbados was confirmed for the position of Vice – Chairperson of the CPA Executive Committee. The position is for a term of one year and the holder is also a member of the CPA Coordinating Committee.

(g) 66th CPA General Assembly: Key Decisions

The General Assembly during the 66^{th} CPC in Ghana was presided over by the CPA President (2022-2023), Rt Hon. Alban Bagbin, MP, Speaker of the Parliament of Ghana and was attended by Members from 102 CPA Branches.

The General Assembly also included a topical debate on food security and sustainability in the Commonwealth, with presenters from CPA Branches including Queensland, Tanzania, Canada, Isle of Man and Turks and Caicos Islands.

Further many important decisions were taken during the course of the General Assembly like CPA Status, Annual report, CVPA Secretary General's Annual appraisal and application for a second and final term, CPA Membership report, CPA future Membership subscriptions, Audited Report and Financial Statement- year end 31st December 2022, Budget and Financial Management Reports, Internal Auditors, Report of the Working Group of CPA Modalities, Matters submitted by CPA Branches to the 66th CPA General Assembly, Network Reports, Future CPC Conferences, Election of new Regional Representatives on the CPA Executive Committee. Delegates also were briefed about the 67th Commonwealth Parliamentary Conference (CPC) to be hosted by the CPA South Wales Branch and Parliament of New South Wales in November 2024.

POST CONFERENCE STUDY TOUR TO CAPE TOWN, SOUTH AFRICA

(a) A note on South Africa

South Africa is a melting pot of cultures and languages, and the political backdrop is just as broad and diverse as the country and its population. Similar to countries such as Germany, Japan, and the United States, South Africa is a constitutional democracy. Besides, it has a three-tier system of government – national, provincial and local.

There are three branches of the South African government, each with a different capital city:

- the executive (the President and Cabinet), based in Pretoria
- the legislature (Parliament), based in Cape Town
- an independent judiciary (the Courts), based in Bloemfontein

The Republic of South Africa is a unitary parliamentary democratic republic. The President of South Africa serves both as head of state and as head of government. The South African government is led by the executive branch, the President, and the cabinet.

(b) The South African Legislature

The Parliament of South Africa consists of two houses:

- the National Assembly and
- the National Council of Provinces (NCOP)



(c) About Western Cape Provincial Parliament

The Western Cape Provincial Parliament (WCPP) is the legislature of the Western Cape province of South Africa. It is in Cape Town.

The Provincial Parliament, along with the other provincial legislatures of South Africa, exists by virtue of Chapter 6 of the Constitution of South Africa and Chapter 3 of the Constitution of the Western Cape. It is unicameral, and consists of 42 members elected by a system of party-list proportional representation.

The Western Cape is unique amongst the provinces of South Africa in calling its legislature the "Provincial Parliament" and the Members of Provincial Parliament (MPPs). The other provinces use the terms "Provincial Legislature" and "Members of the Provincial Legislature".

The Sixth Provincial Parliament was elected on 8 May 2019 in South Africa's 2019 general elections. A majority of the members belong to the Democratic Alliance. Mr. Daylin Mitchel is the Speaker of WCPP.

The legislative power of the Provincial Parliament is restricted to certain fields enumerated in the national Constitution; in some of these fields, the power is shared with the national Parliament. The fields on which the Provincial Parliament may legislate include health care, primary and secondary education, agriculture, transport, and land use planning. It also controls the budget of the provincial government departments.

(d) Visit and Meeting with Western Cape Provincial Parliament

The Assam Legislative Assembly visited the Western Cape Provincial Parliament on 9th October, 2023 as part of its post-Conference study tour for 66th CPC. The Delegation from Assam Legislative Assembly had a very fruitful discussion therein.

At the outset, Mr. Daylin Mitchels, the Hon'ble Speaker, Western Cape Provincial Parliament welcomed the Assam Legislative Assembly delegation. He thanked the delegation for visiting the Western Cape Parliament and made a brief introduction about their practices and procedures. Shri Biswajit Daimary, Hon'ble Speaker, Assam Legislative Assembly offered a summary of the Legislative procedures of India as a whole and Assam in particular. Hon'ble Leader of Opposition, Shri Debabrata Saikia also thanked the Western Cape Provincial Parliament and said that the Assam Legislative Assembly have visited South Africa to learn about their best practices.

Mr. Romeo Adams, Secretary to Western Cape Provincial Parliament then made a brief intervention which was followed by two detailed PowerPoint presentations on the following topics:

- ◆ Law making and oversight in South Africa: Ordinary bills not affecting the Provinces and money bills are introduced in the National Assembly and Ordinary Bills affecting the Provinces are introduced either in the National Assembly or the National Council of Provinces.
- Making of Submissions and Petitions to the Western Cape Provincial Parliament: One interesting feature of submission of petitions is that the petitioner is informed about the progress of his submitted petition every step of the way. A petition can be submitted by registered mail, email, walking in or delivering by hand to a designated official or on the website.

One interesting point mentioned is that the Western Cape Provincial Parliament have cut down on print advertisements which is costly and not effective. They have switched most advertising to social media-facebook, Instagram, snap chat, X (twitter), website, etc which are more effective in view of its increasing use, especially by the younger generation.

At the end, with a sincere gesture of gratitude the Hon'ble Speaker, Assam Legislative Assembly extended warm invitation to the Hon'ble Speaker, Western Cape Provincial Parliament along with the officials to visit Assam in near future. The meeting ended with a vote of thanks by Shri P.S. Gangadhar, the Consul General of India in Cape Town.

OBSERVATIONS AND KEY TAKEAWAYS

The delegation from Assam Legislative Assembly had a very productive first-hand exposure about various aspects during the 66th Commonwealth Parliamentary Conference held in Accra, Ghana along with the pre-Conference study tour to Cairo, Egypt and the post-Conference study tour to Cape Town, South Africa.

The delegation also learnt about various legislative practices and procedures about the respective Parliaments during the Conference as well as the Pre and Post Conference Study tour.

During the deliberation and visit of the Majlis Al – Shiyoukh (Egyptian Senate), Cairo the delegation noted about various procedures, specifically about the podium arrangements. During the laying of the Committee Reports the respective Chairman takes the Chair to present and read out the same during the House Proceedings. They have dedicated sitting provision in the house also for the Chairman of the Committees, below the



Speaker's podium and above the Official's Table - there is the dedicated podium for the Chairman of any committee for presentation and reading out of the Reports etc.

The 66th CPC was an enriching experience for all the participants from Assam. The experience in the SOCATT meeting would also be very beneficial for the participating officers as various parliamentary practices and procedures were presented and discussed.

During the discussions in the Cape Town at the West Cape Provincial Parliament the delegation got to learn about the process of different colors used to print the Bills which were called as the green papers (for the color of the paper),



which is a first step towards making a legislation and gives several solution to policy decisions whereby public and stake holders are invited to make a comment accordingly. After that it is a White Paper which signifies the government's clear intention to make a policy and is more defined than the green paper.

One interesting point mentioned by the Western Cape Provincial Parliament is that they have cut down on print advertisements which is costly and not effective. They have switched most advertising to social media-facebook, Instagram, snap chat, X (twitter), website, etc which are more effective in view of its increasing use, especially by the younger generation. This can also be implemented by the Assam Legislative Assembly by making use of social media for dissemination of information to the public and for the public to submit their petitions online.

Regarding petitions and submissions, the petitioner is informed of the status of his petition every step of the way. This is also a very good practice which can be followed by the Assam Legislative Assembly.
